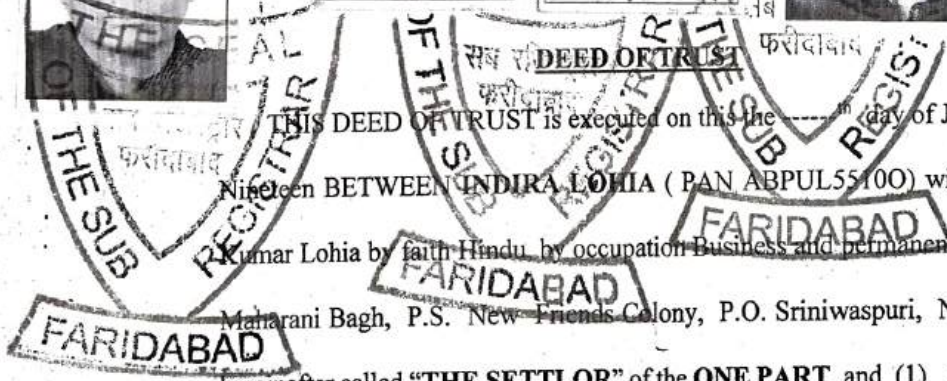

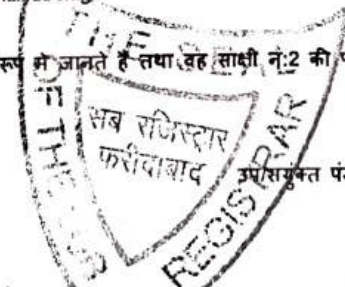

Accordingly a Trust Deed was executed and registered by Additional Registrar of Assurances - III Kolkata on dated 18th day of July Two thousand and Seventeen vide Registration No. IV-190303884 / 2017.

WHEREAS in view of subsequent changes in the trust by resignation of trustee Sh. S. S. Jain and addition of a new trustee Sh. Priyavrat Gupta and further transfer of trust office from Kolkata to Faridabad considering that the trust has established a school named as ‘Manaskati’ in Sector 82 Faridabad and also that all the trustees are resident of Delhi, hence it has been decided by the trustees to amend the trust deed to induct the important changes occurred in the trust time to time and to get the amended trust deed registered by the office of Sub Registrar Faridabad. That in order to effectuate the said decision of the trustees, few necessary amendments are being incorporated in the amended trust deed of the trust.

NOW THIS INDENTURE WITNESSETH that in order to effectuate the said desire, the Settlor has made over to the Trustees a sum of Rs. 10000/- (Rupees Ten thousand only) with intend to part with all her right, title, interest and claim therein and vest the same in the trustees to hold the same together with all additions thereto and accretions thereof and all other properties that may be acquired out of the same or otherwise may hereafter be subject to the Trust (hereinafter referred to as the "TRUST FUND") for the objects of the Trust absolutely and forever upon trust subject to the powers, provisions and declarations hereinafter contained.

1. The name of the Trust is "**H. P. LOHIA FOUNDATION**".
2. The office of the trust shall be situated at Manaskriti School Sector 82 Greater Faridabad 121002 but the Board of Trustees, if unanimous, may open branch or branches within the Indian Union as the Trustees may think expedient from time to time.
3. The Trust fund will be utilized in India for relief of the poor, education and medical relief.
4. The Trustees will have power to utilize the income and/or corpus of the trust fund for all or any of the said purposes as they may decide and without prejudice to the generality of the said power the Trustees will have for attainment of the objects aforesaid power to:

A) Help deserving students by providing financial assistance for higher studies as also give them allowances, scholarships, stipends and help them in all other possible ways.

B) To establish & /or maintain schools, college, hostels or other institutions for imparting education and grant aid to such institutions;

- C) To render help in ailments of needy persons by providing medicines, facilities for treatment and medical assistance &/or by opening dispensaries, hospital, etc and give aid to such activities for the public in general.
- D) To assist promote and/or subscribe to the establishment and maintenance of any institution, association fund, trust or charity for the benefit of general public.
- E) To takeover or amalgamate with itself any other trust institution or society and utilize the same in accordance with the objects of the trust.
- F) To study, spread and propagate Indian Culture especially in its intellectual, spiritual and artistic aspects and for the purpose;
- To maintain a Research Library and a place where scholars can study;
 - To hold educational conferences , seminars etc;
 - To publish articles, papers and books;
 - To give stipends to promising students, artists etc,
- G) To do all such other lawful things or acts as are conducive to the attainment of the above objects or any of them.
- H) In case any one or more objects specified above are held to be not of public charitable nature, in that event, the trustees shall not carry out such object and objects as if the same area not incorporated in these presents so that the validity of the trust created by these presents as a trust for public charitable purpose shall not be effected in any manner.

POWER AND DUTIES OF THE TRUSTEES

5.1 To co-opt if necessary more persons of their choice as trustees who are in blood relation of the trustees and may be useful in the execution of the objects of the trust provided that the number of trustees at no time shall be less than three and more than nine. If the

number of trustees shall fall below the minimum number above mentioned, the continuing trustees/trustee shall be entitled to act for the purpose of appointment of new trustees and shall also be authorized to do all such acts as may be necessary for the preservation and protection of the trust fund.

5.2 To accept donations, contributions, grants, subscriptions in cash or in kind for achieving the objects of the trust.

5.3 To apply the whole or part of the income or accumulation thereof or whole or part of the corpus of the trust fund for one or more of the objects of the trust as the trustees may decide from time to time.

5.4 To invest and keep invested the trust fund either in the purchase or mortgage of immoveable properties or in other modes of investments permissible under section 11(5) of Income Tax Act, 1961 and to convert, alter income Tax Act, 1961 and to convert, alter, vary or transpose such investments from time to time.

5.5 To let out, demise any immoveable property comprised in the trust fund for such period and at such rent on such terms and conditions as the trustees shall think fit for the benefit of the trust.

5.6 To open account with any bank or banks, to operate such account and to give instructions to the bank and to provide for opening and operation of such account by one or more of the trustees or any agent appointed by the trustees and close the same also if so required.

5.7 To adjust, settle, compromise, compound refers to arbitration all actions, suits, claims, demands and proceedings regarding the properties and affairs of the trust.

5.8 To appoint Constituted Attorneys or Agents and to delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such Attorneys or Agent and to appoint other or others in his or their place.

- I. All matters will be decided by majority and three trustees shall form a quorum for meeting of trustees.
 - II. Resolution passed without any meeting of the trustees and evidenced in writing under the hands of majority of the trustees on circulation shall be as valid and effectual as a resolution duly passed at a meeting of the trustees.
 - III. The Chairman, in a meeting of the Board of the Trustees will, in case of equality of votes, have a casting vote.
 - IV. Any trustee who is unable to attend the meeting for any reason may forward his views in writing on any matter to be discussed at such a meeting of the Board, before the time of the meeting and his views shall be duly taken into account in deciding that matter.
- 10 The Board of Trustees may elect from amongst themselves a Chairman of the Board. The Trustees may meet any number of times during a year but not less than once a year. The notice of the meeting will normally be dispatched at least fourteen days before the date of meeting but not less than seven days if so urgently required depending upon the circumstances prevailing the.
- 11 The accounting year of the trust will run from April to March for which the trustees shall keep true and accurate accounts of all monies received and spend by them on behalf of the trust which will be audited and certified by the professional auditors who will be appointed by trustees from time to time.
- 12 The proceedings of the meeting of the board shall be recorded regularly in the Minute's Book and the same signed by the chairman of the meeting or senior most trustees present at that meeting.

13 The Board may at its discretion, decide to open any number of saving as well as current accounts as it may deem fit and if so required, may close the same also. These accounts

shall be operated or closed by persons duly authorized in this regard by the Board from time to time.


- 14 It is hereby declared that the trust is irrevocable. If the same fails for any reason in the opinion of 3/4th of the trustees, the net assets of the trust, both moveable and immovable, shall be handed over to any recognized trust, society or institution operating at Faridabad having similar charitable objects, by passing a special resolution by 3/4th of the trustees.
- 15 The Trust is hereby expressly declared to be public charitable trust and all the provisions of this deed are to be construed accordingly. In case of difference of opinion regarding meaning of any word or phrase appearing in the above text, the decision of board of trustees shall be final and binding on all concerned.

At present this Trust has movable and immovable assets as Trust funds available in bank accounts of trust and school land and building in Sector 82 Faridabad under the ownership of the trust.




5.9 To appoint or make provision for the appointment of any of the trustees as Managing Trustee/ Chairman or otherwise for the purpose of the administration of the trust in such manner and subject to such rules and regulations as the trustees may decide.

5.11 To set apart the whole or part of the income or the corpus or part thereof for any of the objects of the trust.

5.12 To amalgamate this trust with any other institution having charitable objects altogether or in part similar to those mentioned in these presents.

6 All agreement, contracts, instruments, documents required to be signed or executed on behalf of the Trust may be signed by any two of the trustees and shall be as effective and binding as if it were signed by all the trustees.

7 The Trustees shall be accountable only for such moneys , securities and funds as shall actually come into their hands and shall not be answerable or accountable for neglect default acts of omission or commission of the other trustees nor of any agent appointed by them nor of any banker and other person with whom the trust properties or any securities may have been deposited or handed over unless caused by their willful neglect or default.

8 The trustees will not be entitled to receive any remuneration as trustees but may reimburse themselves of all expenses actually incurred by them in connection with the trust or their duties relating thereto.

9 The trustee may from time to time frame rules for the conduct of the affairs of the trust and regularizing the meeting of trustees. In the absence of such regulations:
